| RULES OF THE GIVEAWAY "UNILEVER EURO 2024" |
| Name of the trading company that is the organiser of the prize game |
| Article 1 |
| Organiser of the prize game "UNILEVER EURO 2024" is the company for trade and service NEXT SHPK with headquarters at AZIZ ABRASHI str no.86, Prishtina, with fiscal number 60018297 and registry number 810535916 |
| Products for the advertising of which the raffle is organized |
| Article 2 |
| The prize game is organized for the purpose of advertising products from the range of the Unilever brands (Dove, Rexona, Axe, Vaseline) in the points of sale of VIVA FRESH stores all over Kosovo. |
| Name, description and duration of the prize draw |
| Article 3 |
| The official name of the giveaway is "UNILEVER EURO 2024" |
| "UNILEVER EURO 2024" is a prize game organized to reward its consumers who, with a receipt of at least 5 euro including VAT, from purchased products from the Unilever brand (Dove, Rexona, Vaseline) from the points of sale of VIVA FRESH, will send an SMS message to a mobile phone: 51666, with the following content: fiscal receipt number, (blank space), date of the receipt. |
| Fiscal receipt number in the sense of these Rules is the fiscal receipt issued in the points of sale of VIVA FRESH, on the territory of the Republic of Kosovo, issued during the period of the prize game and on the same fiscal receipt there are purchased products from the assortment of the Unilever brands (Dove, Rexona, Axe, Vaseline), in the amount of at least 5 euro including VAT. |
| The prize draw starts on 15/04/2024 and will last until 15/05/2024. |
| Territory where the prize draw is held, i.e. where the payment for participation in the prize draw is made |
| Article 4 |
| The prize game is organized in the entire chain of VIVA FRESH that are on the entire territory of the Republic of Kosovo. |
| Information about the prizes in the sweepstakes |
| Article 5 |
| The prize game has a prize pool of 6 tickets to EURO 24 and 14 APPLE products in total. The prizes that will be awarded are the following: |

| The amounts of the raffle are defined as in the table and there will be no possibility to replace the prizes with other prizes or to replace the prizes with a cash value or a value voucher. |
| The prize fund is provided by the organiser of the prize game. |
| Conditions for participation in the prize draw |
| Article 6 |
| Right to participate in the prize game "UNILEVER EURO 2024" is open to everyone over 18 years of age. Minors are not eligible to participate in the prize draw. |
| Right to participate in the prize game "UNILEVER EURO 2024" has every consumer who buys products from the Unilever brands (Dove, Rexona, Axe, Vaseline) in the amount of at least 5 euro including VAT, in the points of sale specified in Article 4 of these Rules of the Prize Game and will send a fiscal receipt number that will contain the purchased products from the Unilever brands and the date of the fiscal receipt with an SMS message via mobile phone. |
| The participants in the prize game are obliged to keep the fiscal receipt until the end of the prize game, and the participants who received a prize should keep the fiscal receipt until the reliability of the same is determined. |

Employees who work for the organiser of the prize draw, NEXT SHPK, and members of their immediate family, do not have the right to participate in the prize draw.

Course of the procedure of the arrangement, that is, the implementation of the prize game

Article 7

After purchasing products from the Unilever brands (Dove, Rexona, Axe, Vaseline), in the amount of at least 5 euro including VAT, in the points of sale listed in Article 4 of the Rules of the prize game, the participants in the prize game send an SMS message to number 51666 with the following content:

the fiscal number number (blank space) and

the date of the fiscal receipt

Example of SMS message format: 12345678 15.04.2024

The price of one message is 0.05 euro including VAT.

Participants in the prize game will be able to send SMS messages from 15/04/2024 from 00:00:01 to 15/05/2024 until 23:59:59.

By participating in the prize game, the participants confirm that they are fully familiar with the provisions of these Rules and express their consent to accept them. One person, in the prize game, can participate an unlimited number of times, but using different fiscal receipts from purchased products of Unilever brands (Dove, Rexona, Axe, Vaseline).

The feedback is as follows:

If the sending of the message is successful, the participant will receive a confirmation SMS message for participation and a link to the rules where he can read the official game rules in detail.

If sending the message is unsuccessful, the participant will receive a return SMS message that the receipt number has already been previously used or that an incorrect content format has been sent, followed by the instruction messages.

Method of familiarizing the participants in the prize game with the rules of the game

Article 8

During the duration of the raffle, the organiser will inform potential participants about the rules of participation through posters, flyers that will be published at all points of sale where the raffle will be held. As well the rules of the prize game on the organiser's website, www.next-ks.com

Place, time, method, procedure and control of the drawing of the prizes, that is, of the determination of the winnings and the winners.

Article 9

Prize winners will be drawn at random using computer-based drawing software, which will select from a database based on the message sent by each entrant.

In addition, reserve prize winners will be drawn from the same software, in the event that one of the winners does not submit a valid fiscal receipt that has been won, and does not collect the prize within the stipulated period or if it is not properly identified.

Photocopies of fiscal receipt are not accepted as reliable evidence.

The prize winners will be drawn on May 16, 2024 at 10:00.

Prize winners will be contacted by phone within 3 working days, on the number from which the SMS messages were received, about the prize and the place where they can pick up the prize.

Method of announcing the results, that is, the prize winners

Article 10

The report of the draw is published within 3 days from the day of the draw on the official website of organiser, www.next-ks.com

The drawing report will contain data stating the number of the winning fiscal receipt and the phone number of the winner from which the SMS message was sent, with the last two digits of the phone number hidden.

Method of presenting the awards

Article 11

Prize winners will be able to pick up the prizes at the organiser's headquarters, in the premises of NEXT SHPK, within 15 days of the announcement of the prize winners.

Prize winners are obliged to submit an original copy of a fiscal receipt when picking up the prize, in order to determine its reliability.

Each of the winners should pick up the prize in person, identify themselves with a personal identification document and present the winning fiscal receipt.

If one of the prize winners does not submit a fiscal receipt, damages or loses it, they lose the right to collect the prize.

If the prize is not collected within the stipulated period or if the winning fiscal receipt is not submitted when the prize is collected and the person is not identified when the prize is handed over, the winner loses the right to the prize, and the prize will be awarded to the first reserve winner.

Responsibility

Article 13

The entire prize fund will be provided by the organiser of the prize game, NEXT SHPK

The organiser has no responsibility that may arise from the use of the prizes, as well as the payment of damages or lawsuits that are in any way related to the use of the prizes

The potential participant in this prize draw understands and agrees that he is participating in by participating in the prize draw, the participant agrees that if he is drawn for any of the prizes, his personal information such as the phone number with the last two digits hidden will be made public.

The organiser is not responsible in the event that the received prize cannot be given or used due to the impossibility of the potential winner or his representative to call and receive the prize within the specified deadlines or due to other technical or legal obstacles related to the specific winner or his representative and due to the circumstances caused by force majeure, regulatory or legal restrictions or other circumstances.

Termination of the sweepstakes

Article 14

The raffle may be terminated in case of force majeure, including the inability of the organiser - NEXT SHPK to perform the raffle due to reasons beyond its control.

In this case, the organiser - NEXT SHPK should inform the consumers about the termination of the prize draw on the website www.next-ks.com

Processing of personal data

Article 15

The organiser - NEXT SHPK, will use and process the personal data of the winners exclusively for the purposes of the prize game.

Each entrant in the prize draw, by entering to participate in the prize draw, is deemed to have consented to the processing of his personal data by the organiser of the prize draw, for the purposes of the prize draw.

Personal data, such as: first and last name, citizen's identification number, address, telephone number, as well as an inspection of a personal identification document, are required for the purpose of checking the right to participate in the prize draw.

The personal data of the winners will not be used for purposes other than those mentioned above.

The organiser - NEXT SHPK undertakes not to pass on personal data to third parties, except if it is necessary to carry out the prize draw.

Prohibition of participation in the prize game for employees of the organiser, as well as members of their immediate families

Article 16

All employees of the organiser of the prize game, as well as members of their immediate families, are not entitled to participate in the prize game.

Final Provisions

Article 17

By fulfilling the rules for participation in the prize draw, participants accept the provisions of these rules. These rules are mandatory for the participants and will be valid until the end of the prize game, i.e. the end of the deadline for picking up the prizes.
